At 6:00 p.m. Mayor Jordan called the meeting to order, announced a quorum present, and led the Invocation and Pledges.

PUBLIC COMMENTS - None

DISCUSSION/ACTION ITEM:

The only action item was to Discuss and Consider Approval of an Interlocal Agreement between the County of San Saba and the City of San Saba regarding Emergency Medical Services. City Manger Weik explained to the Council that in this Interlocal Agreement, the City will be responsible for forty-four percent (44%) of the EMS Services. Hamilton County EMS currently has two (2) large ambulances with two full Staff 24/7. They also have a backup Ambulance in Goldthwaite. We previously only had one (1) Ambulance here. The additional six thousand dollars it will cost the City is a no-brainer since we will have 3 additional men. Mayor Kenneth Jordan added that Hamilton County EMS services are unbelievable, far and above what we had, and they also offer more stabilization services. Mayor Pro-Tem Robert Whitten made a motion to Approve the Interlocal Agreement between the County of San Saba and the City of San Saba regarding Hamilton County Emergency Medical Services, seconded by Alderman Oleta Behrens, and was unanimously approved.

As there was no further discussion, the meeting adjourned at 6:08 p.m. and immediately began the Budget Workshop. City Manager Stan Weik presented the 2020-2021 budget for General Admin, (Expenses), Municipal Court (Expenses), Emergency Management (Expenses), Health Services (Expenses), and Rec. Center (Expenses).

No final decisions were made regarding budgets at this meeting.
