JOINT ELECTION AGREEMENT

This Agreement is entered into between the City of San Saba acting herein by and through its City Council, and the San Saba Independent School District acting by and through its Board of Trustees for the purpose of conducting joint elections for members of their respective governing bodies, do hereby agree as follows:

- 1. The San Saba Independent School District and City of San Saba mutually agree to conduct a joint election at the City Council Chambers at 303 S. Clear Street, San Saba, Texas on May 2, 2020 and;
- 2. The San Saba Independent School District will authorize the City of San Saba to appoint Election Officials and set compensation at an hourly rate not less than the federal minimum hourly wage, and
- 3. The San Saba Independent School District will reimburse the City of San Saba one-half (1/2) of all costs incurred from joint election, and;
- 4. In the event either entity is not required to hold an election, the entity conducting an election will be responsible for all election expenses; and
- 5. The San Saba Independent School District will authorize the City of San Saba to conduct all aspects of the early voting and will reasonably compensate the City of San Saba for rental of council chambers to conduct the early voting and election day, and;
- 6. Each entity will provide its own ballot box, its own ballots, canvass their own election results, and issue certificates of election to candidates elected, and;
- 7. Each entity will be the custodian for their election records.
- 8. Per Section 141.040 of the Election Code, the City Secretary will prepare the joint filing period notice to be posted at each filing authority entity.
- 9. The City of San Saba will publish the joint applicable Notice of Election in the San Saba News & Star.

RESOLUTION 2020-03

A RESOLUTION OF THE CITY OF SAN SABA TO WAIVE AN ORDINANCE DEFINING NOISE NUISANCES

WHEREAS, the City of San Saba desires to regulate and oversee any unreasonable loud, disturbing, unnecessary noise which causes material distress, discomfort or injury to persons of ordinary sensibilities in the immediate vicinity.

WHEREAS, the playing of any radio, phonograph or other musical instrument in such manner or with such volume, particularly during the hours between 10 p.m. and 7 a.m. as to annoy or disturb the quiet, comfort or repose of persons of ordinary sensibilities in any dwelling, hotel or other type of residence is prohibited.

WHEREAS, Lynn Blankenship, President of the San Saba County Historical Museum, San Saba, Texas, has asked the City Council to waive Ordinance No. 1967-4 to allow music to be played at Mill Pond Park on March 7, 2020 until 12:00 midnight for a Historic Celebration, "Night at the Museum".

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of San Saba is hereby authorizing the playing of music from 10:00 to 12:00 midnight on March 7, 2020 at Mill Pond Park.

Passed and approved this 10th day of February, 2020.

DISCUSSION/ACTION ITEMS:

The first action item was to discuss and consider approval of the Financial Audit. Kevin Shahan was present to present audit findings to the Council and answered questions. A copy of the Audit was provided to the Council Members, Letter to Management and Council, Audit Summary, and Financial Statements. Mr. Shahan gave the audit a clean opinion and state there were no extra additions. He addressed the Council and said over all the City is in good shape and the Expenditures don't seem to be going up and the Reserves are in great shape. Mr. Shahan stated "the financial statement disclosures are good shape with cash going in and cash going out and did not identify any deficiencies in the internal control. He explained that sales taxes were down 9% overall from 2018, but the Pipeline was going through in 2018 and that made the difference. He also said the City is very consistent. Mr. Shahan thanked the Council and asked if anyone had any questions. Alderman Oliver made a motion to approve the Audit as presented by Kevin Shahan, seconded by Alderman Behrens and was unanimously approved by the Council.

The second action item was to Discuss, Consider, and Approve Resolution No. 2020-04, a Resolution Authorizing a Planning Service Agreement for Project Implementation in conjunction with TxCDBG Planning and Capacity Building Contract No. 7219114. Alderman Nelson made a motion to approve Resolution No. 2020-04, appointment of Planning Services to Jacob & Martin, LLC, regarding the 2019 Planning and Capacity Building Fund TxCDBG Program of the Texas Department of Agriculture, seconded by Alderman Oliver, and was unanimously passed.

WHEREAS, The City of San Saba is seeking to contract with firm to provide planning services associated to Project Implementation for the continuance of this Planning & Capacity Building Fund - Texas Community Development Block Grant (TxCDBG) contract;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS;

That the Mayor be authorized to sign a contract with Jacob Martin, LLC of Abilene, Texas for the City of San Saba, Texas to provide planning services associated to Project Implementation for the 2019 Planning & Capacity Building Fund - Texas Community Development Block Grant (TxCDBG) Program of the Texas Department of Agriculture (TDA).

Alderman Oliver made a motion to approve Resolution No. 2020-05, seconded by Alderman Amthor, and was unanimously passed.

- a revised TxCDBG Depository/ Authorized Signatories Designation Form (Form A202).

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS, AS FOLLOWS:

The Mayor and Mayor Pro-Tem, be authorized to execute contractual and environmental review documents between the Texas Department of Agriculture and the City for the TxCDBG contract.
