DISCUSSION/ACTION ITEM:

The first action item was to Discuss and Consider approval of Ordinance No. 2019-05 amending Ordinance No. 2017-09 Specifically "Exhibit A" Fee Schedule for certain city services. City Manager Weik provided the Council with a State-wide comparison of Utility rates and explained that the City of San Saba is well below the state average. He explained that the increase is due to the increase in chemicals that are required to go into our water supply and parts for maintenance on Utility services have become more expensive. Alderman Oliver made a motion to approve Ordinance No. 2019-05 amending Ordinance No. 2017-09 Specifically "Exhibit A" Fee Schedule for certain city services, the motion was seconded by Alderman Whitten, and was unanimously approved by Council.

CITY MANAGER'S REPORT

City Manager Weik reported on the following activities in the City of San Saba: the Texas Mid-West Association Meeting will be in San Saba and they will be touring our City; the Duck Relocation

Program will start up again soon, can't touch the Mallard Ducks; the Parks Department has been putting up signs not to feed the ducks and asking the public to feed the ducks away from the beach; Mr. Macias is putting up a fence on the east side of Mill Pond and the City has sent letters for him to mow the grass to the west of the entrance and he told the Code Enforcement to fine him.

OTHER REPORTS

Scott Glaze, Public Works Director reported that the waterline contractor is grinding hard toward the end of the project, but have been having boring issues due to the hard rock; looking to be complete by the end of September; the City has had several Change Orders on this project; we have had several complaints regarding sprinkler systems; Street Department cleaned the ditch at Mill Pond Park; there was an EEA1 Alert today that the City fell under and that means that we would need tp borrow electricity from another source due to the extreme heat; they are asking that everyone reduce the electricity use from 3:00 p.m. to 7:00 p.m.

As there was no further discussion, the meeting adjourned at 6:33 p.m. to the Budget Workshop.

Council members took a brief recess before beginning the Budget Workshop. The Budget Workshop for the 2018-2019 fiscal year was discussed. This was the final Budget Workshop meeting and Debt Service (Revenue and Expenses), the Revenue portion of all department budgets, with the exception of Golf were discussed. No final decisions were made regarding budgets at this meeting.

The meeting adjourned at 6:59 p.m.
