RESOLUTION 2023-39

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS, TO AUTHORIZE THE CITY TO ENTER INTO AN AGREEMENT WITH (TXDOT) TEXAS DEPARTMENT OF TRANSPORTATION FOR THE CLOSURE OF ONE OF THE STATE'S RIGHT-OF-WAY'S (HWY 190 OR WALLACE STREET); AND AUTHORIZING THE MAYOR AND/OR CITY MANAGER TO ACT AS THE CITY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE CONTRACT.

WHEREAS, the City of San Saba has requested the temporary closure of Wallace Street for the purpose of the Christmas Parade on December 9th, 2023 at 6:30 p.m.; and

WHEREAS, the Parade will be located within the City's incorporated area; and

WHEREAS, the State, in recognition of the public purpose of the Parade, wishes to cooperate with the City so long as the safety and convenience of the traveling public is ensured and that the closure of the State's right-of-way will be performed within the State's requirements,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS: that the City Council authorizes the Mayor and/or City Manager to act as the City's Executive Officer and authorized representative in all matters pertaining to the contract with TxDOT.

RESOLUTION NO. 2023-40

A RESOLUTION CLOSING THE 300 AND 400 BLOCKS OF EAST WALLACE STREET TO PARKING ONE HOUR PRIOR AND DURING THE ANNUAL CHRISTMAS PARADE IN DECEMBER; PROVIDING FOR BARRIERS AND WARNING DEVICES; SEVERABILITY AND AN OPEN MEETING CLAUSE

WHEREAS, pursuant to Chapter 311 of the Texas Transportation Code, a general-law municipality such as San Saba has exclusive control over the highways, and streets of the municipality;

WHEREAS, City of San Saba Downtown business owners have asked the City Council to prohibit parking on the 300 and 400 blocks of East Wallace during a specific time frame;

WHEREAS, parking would be prohibited in this specific area for one hour prior and during the annual Christmas Parade;

WHEREAS, prohibiting parking in this area during this time will not harm public right of way uses by the City nor hinder emergency services personnel from protecting the public;

WHEREAS, prohibiting parking in this area during the parades will serve and protect the public health and safety of all citizens and visitors to San Saba.

WHEREAS, City Police staff are authorized and empowered to install barriers to prevent parking in this area during this time.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS, THAT: the 300 and 400 blocks of East Wallace Street will be closed to parking for one hour prior to and during the annual Christmas Parade.

CITY MANAGER'S REPORT

City Scott Edmonson reported on the following activities in the City of San Saba: Introduced Wayne Yarbrough to the City Council as the new Code Enforcement Officer, explaining that this was a lateral move from the Parks Department; it is looking like it is going to be toward the end of October before the crews start the Splash Pad; we received the preliminary drawings for the DRP Grant regarding the sidewalk installation to approve so they can submit the Environmental Review; took several vehicles to Goldthwaite to be auctioned off; the Park's Department has been installing Christmas lights and other departments have been helping due to the shortage of employees in the Parks Department; Bruce Stewart will be retiring at the end of the year and the City will be looking to hire for that position; the Annular Eclipse will be this Saturday; Scott Glaze and Bruce Stewart are

having issues with a toilet at the Health Services Center and trying to get that resolved; the 'Welcome to San Saba' Rock on the corner of S. High and E. Commerce Streets is a really addition to the City and very thankful to the donors of this attraction; Sarah Saldivar nominated the Community Foundation for the Best Downtown Partner under 50K Category through the Texas Downtown Association and they are one of three that have been chosen for the #1 spot.

OTHER REPORTS

Scott Glaze, Public Works Director reported: the Generation is in place, and they have upgraded the electricity at the water plant; Chase Pecan project is still going on and they are still pouring concrete.

Wayne Yarbrough, Code Enforcement Officer reported: the Code Enforcement is a wonderful job, and I will do my very best to do the best job I can.

As there was no further business, the meeting adjourned at 6:15 p.m.
