NOW, THEREFORE, this agreement is made and entered into this 9th day of December, 2014, between COUNTY and CITY, for the purpose of filling the position of Emergency Management Coordinator, and that the COUNTY offices will be used for said position, for a term beginning October 1, 2014, and extending until September 30, 2015.

For and in consideration of the sum of Three Thousand Three Hundred Forty-Seven dollars and Sixty-five cents (\$3,347.65) per annum, payable to COUNTY, as salaries and mutual covenants hereinafter promised or agreed to be undertaken, the COUNTY shall assume the duties of Emergency Management Coordinator, administer all office duties and be housed in the San Saba County Courthouse in San Saba, Texas, while performing said duties.
