A RESOLUTION REGARDING A FINANCING AGREEMENT FOR THE PURPOSE OF PROCURING A "VEHICLE AND RELATED EQUIPMENT".

WHEREAS, City of San Saba desires to enter into that certain Financing Agreement, by and between Government Capital Corporation and City of San Saba, for the purpose of procuring a "Vehicle and Related Equipment". The City desires to designate this Agreement as a "qualified tax exempt obligation" of the City for the purposes of Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended. City of San Saba desires to designate the City Administrator as an authorized signer of the Agreement. The City declares its intent within the meaning of Treasury Regulation § 1.150-2, as promulgated under the Internal Revenue Code of 1986, as amended to use loan proceeds for reimbursement of expenditures related to the Property.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN SABA:

<u>Section 1.</u> That the City enters into a Financing Agreement with Government Capital Corporation for the purpose of procuring a "Vehicle and Related Equipment".

<u>Section 2.</u> That the Financing Agreement, by and between the City of San Saba and Government Capital Corporation is designated by the City as a "qualified tax exempt obligation" for the purposes of Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended.

<u>Section 3.</u> That the City of San Saba designates the City Manager as an authorized signer of the Financing Agreement, by and between City of San Saba and Government Capital Corporation.

<u>Section 4.</u> That the City will use loan proceeds for reimbursement of expenditures related to the Property.

This Resolution has been PASSED upon Motion made by Council Member Oleta Behrens, seconded by Council Member Shawn Oliver by a vote of 4 to 0 and is effective this 10th day of May, 2016.

The third discussion item was to discuss and consider approving a Public Utility Easement to the City of San Saba from the following Grantors: a) William A. Broyles; b) Donny Smith; and Sam Uli for the purpose of installing water and sewer lines for the availability of utility services to City of San Saba Customers in the Hopeview Addition and adjoining properties as depicted and/or described in Exhibit "A". Mr. Weik explained to the Council that the Hopeview Addition is located West of the ALCO Building and the Addition is located outside of the City limits. He also explained that Sam Uli had requested services and that Donny Smith would also need services for the property he purchased. Mr. Weik explained that the City will charge a Development Fee to the customers that wish to obtain services in order to recoup the installation of the water and sewer lines. He also referred to Exhibit A explaining the location of the water and sewer lines. On a motion by Alderman Oliver, seconded by Alderman Amthor, the City Council unanimously agreed to approve a Public Utility Easement to the City of San Saba from the following Grantors: a) William A. A 20' wide water and/or wastewater line easement which extends 10' on each side off of center of the line shown and which easement area located on that certain tract or parcel of land, lying and being situated in San Saba County, Texas, as depicted and/or described in **EXHIBIT** "A" attached hereto and made a part hereof for all purposes (the "Easement Tract").

Together with the right of ingress and egress over my adjacent lands to or from said right-of-way for the purpose of construction, placement, operation, maintenance, repair, rebuilding, relocation, replacement, upgrade, decommissioning and/or removal of said lines and appurtenances.

Grantor covenants and agrees to use the Easement Tract only in those ways consistent with the easement granted herein, and further covenants and agrees not to construct any building or other structure on the Easement Tract or to do anything that would impair, damage or destroy the lines or appurtenances located thereon or unreasonably interfere with Grantee's access thereto. The covenants and agreements set forth herein are covenants running with the land, and shall fully bind Grantor and its successors and assigns.

TO HAVE AND TO HOLD the same perpetually to Grantee and its successors and assigns together with the right and privilege at any and all times to enter the Easement Tract, or any part thereof, for the purpose of construction, placement, operation, maintenance, repair, replacement, upgrade, decommissioning and removal of water and/or wastewater public utility lines and associated appurtenances and making connections therewith provided.

Grantor does hereby covenant and agree to WARRANT AND FOREVER DEFEND title to the easement herein granted unto the Grantee, its successors and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof subject to the matters set forth herein.

Tony Guidroz, EDC Director, reported that the Catkins Ball was a success raising about \$96,000.00 in the open Auction and \$15,000.00 with the silent auction; Shady Shores Nursing home is about two to three weeks away from opening and looks fabulous; Pecan Capital Trade Days had 17 vendors; Everything is looking good and should be starting demolition soon; San Saba scored high on points for the new apartment complex; Dennis Hardman broke ground and will have a Bakery and Office; Downtown Farmers Market started last Wednesday.
