PUBLIC HEARING

The City of San Saba will hold a public hearing at 6:00 PM on May 14, 2024, at City Hall, 303 S. Clear Street, San Saba, Texas, to receive comments from the Public regarding the following:

- 1) James B. and Heloise H. Lebow are requesting that the San Saba City Council approve to permanently close for public use and purchase an Alleyway located within the City, approximately 1,000 square foot and bordered on the West side by Lots 1, 2, 3, and 4 of Block 6 of the Lindley Addition and bordered on the East side by Lots 1, 2, 3, and 4 of Block 13 of the Lindley Addition, is approximately one hundred (100) feet in length by ten (10) feet in width.
- 2) Kevin L. and Monica M. Shahan are requesting that the San Saba City Council approve to permanently close for public use and purchase an Alleyway located within the City, approximately 240 square foot being a portion bordered on the North side of the South ½ Block 63 of the Harwood & Fentress Addition, is approximately sixty (600 feet in length by four (4) feet in width.
