PUBLIC HEARING

The City of San Saba will hold a public hearing at 6:02 PM on April 14th at City Hall, 303 S. Clear Street, San Saba, Texas to receive comments from the Public regarding the following:

1. Zoning Change to the City of San Saba's Ordinance for property located at 809 W. Gulf Street, San Saba, Texas, and Legal Description, Riverside Addition, Block 1, Lot 8, 110'x47' x 99.5'x46.5' currently zoned Light Industrial (L-1) to be rezoned to Commercial (C-2).

The Planning & Zoning Commission met in open session on Wednesday, March 18, 2020 and recommended on a 4 to 0 vote to approve the Zoning Change from Light Industrial (L-1) to Commercial (C-2) for property located at 809 W. Gulf Street.

PROCLAMATION

CHILD ARUSE PREVENTION MONTH

- WHEREAS, last year in Texas there were 242,103 reports of child abuse or neglect investigated in Texas; and
- WHEREAS, more sadly, 235 abuse-related child deaths in Texas in 2019; and
- WHEREAS, child abuse and neglect prevention is a community responsibility, and finding solutions depends on involvement among all reasonable people; and
- WHEREAS, effective child abuse prevention programs succeed because of partnerships among the public, social service agencies, and local schools, religious organizations, law enforcement agencies, and active business/community leaders; and
- WHEREAS, everyone in San Saba County must become more aware of the child abuse crisis and consider helping raise our children in a safe, nurturing environment;
- NOW, THEREFORE, the City of San Saba and the Commissioners Court of San Saba County do hereby jointly proclaim the month of April 2020 to be Child Abuse Prevention Month in San Saba County and urge all persons to work together with our County Child Welfare Board, CASA (Court Appointed Special Advocates), and the Hill Country Children's Advocacy Center to help reduce child abuse and neglect significantly in the years to come.

RESOLUTION 2020-12

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS, TO AUTHORIZE THE CITY TO ENTER INTO AN AGREEMENT WITH (TXDOT) TEXAS DEPARTMENT OF TRANSPORTATION FOR THE CLOSURE OF ONE OF THE STATE'S RIGHT-OF-WAY'S (HWY 190 OR WALLACE STREET); AND AUTHORIZING THE MAYOR AND/OR CITY MANAGER TO ACT AS THE CITY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE CONTRACT.

WHEREAS, the City of San Saba has requested the temporary closure of Wallace Street for the purpose of the Rodeo Parade on June 13th, 2020 at 10:00 a.m.; and

WHEREAS, the Parade will be located within the City's incorporated area; and

WHEREAS, the State, in recognition of the public purpose of the Parade, wishes to cooperate with the City so long as the safety and convenience of the traveling public is ensured and that the closure of the State's right-of-way will be performed within the State's requirements,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS: that the City Council authorizes the Mayor and/or City Manager to act as the City's Executive Officer and authorized representative in all matters pertaining to the contract with TXDOT.

RESOLUTION NO. 2020-13

A RESOLUTION CLOSING THE 300 AND 400 BLOCKS OF EAST WALLACE STREET TO PARKING ONE HOUR PRIOR AND DURING THE ANNUAL RODEO PARADE IN JUNE; PROVIDING FOR BARRIERS AND WARNING DEVICES; SEVERABILITY AND AN OPEN MEETING CLAUSE

WHEREAS, pursuant to Chapter 311 of the Texas Transportation Code, a general-law municipality such as San Saba has exclusive control over the highways, and streets of the municipality;

WHEREAS, City of San Saba Downtown business owners have asked the City Council to prohibit parking on the 300 and 400 blocks of East Wallace during a specific time frame;

WHEREAS, parking would be prohibited in this specific area for one hour prior and during the annual Rodeo Parade;

WHEREAS, prohibiting parking in this area during this time will not harm public right of way uses by the City nor hinder emergency services personnel from protecting the public;

WHEREAS, prohibiting parking in this area during the parades will serve and protect the public health and safety of all citizens and visitors to San Saba.

WHEREAS, City Police staff are authorized and empowered to install barriers to prevent parking in this area during this time.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS, THAT: the 300 and 400 blocks of East Wallace Street will be closed to parking for one hour prior to and during the annual Rodeo Parade.

APPROVED this the 14th day of April, 2020.

ORDINANCE 2020-04

AN ORDINANCE AMENDING THE BOUNDARIES OF A ZONING DISTRICT WITHIN THE CITY OF SAN SABA, TEXAS

WHEREAS, Casey Null applied to the Planning and Zoning Commission requesting that Block No. One, Lot Number Eight, Riverside Addition Subdivision, located at 809 West Gulf Street be changed from L-1 "Light Industrial District" to C-2 " Local and through highway business district" in order to open a Gym in the building on property;

WHEREAS, the said Planning and Zoning Commission proceeded to hear said zone changes in accordance with the requirements of the Zoning Ordinance of the City of San Saba, Texas; and,

WHEREAS, the said Planning and Zoning Commission, after duly considering said zone changes in accordance with the provisions of said Ordinance, did recommend to the City Council of the City of San Saba that such requested zoning changes be granted; and,

WHEREAS, the City Council of the City of San Saba did give notice as required by said Zoning Ordinance for a public hearing to be held on same in accordance with the said Zoning Ordinance, which hearing was set for Tuesday, April 14th, 2020 at 6:00 p.m.; and,

WHEREAS, after deliberation on the facts involved in the zoning change, the City Council of the City of San Saba is of the opinion that such zoning changes should be made.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of San Saba that the property located at 809 West Gulf Street be changed from L-1 to C-2 zoning classification.

RESOLUTION No. 2020-14 Regarding Limited English Proficiency Plan City of San Saba, Texas

Whereas, the City of San Saba, Texas, (hereinafter referred to as "City of San Saba") has been awarded TxCDBG funding through a TxCDBG Grant from the Texas Department of Agriculture (hereinafter referred to as "TDA").

Whereas, the City of San Saba, in accordance to take reasonable steps to provide meaningful access to federally funded grant programs for all persons with limited English proficiency.

Whereas, the City of San Saba, in consideration for the receipt and acceptance of federal funding, agrees to comply with all federal rules and regulations including those rules and regulations governing how appropriate language assistance will be given.

WHEREAS, The City of San Saba, Texas, establishes a Limited English Proficiency Plan for the City to comply with the Texas Community Development Block Grant (TxCDBG) PROGRAM from TDA, therefore keeping with policy and procedures consistent with HUD and applicable state statutes governing limited language assistance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN SABA, TEXAS, that the CITY OF SAN SABA ADOPTS THE FOLLOWING:

I. LIMITED ENGLISH PROFICIENCY (LEP) STANDARDS:

The City of San Saba, Texas, will provide assistance to all persons with limited English proficiency to have meaningful access to vital documents including environmental notices, citizen participation notices, and civil rights notices. These documents will be translated upon request, published and posted in English and LEP language as determined by census information.

Passed and approved this 14th day of April 2020.

City Manager Weik gave a gave a brief report on the following activities in the City of San Saba: Mr. Weik said he would like to compliment the Citizens of San Saba because as you drive around town, the vast majority are doing as they are asked; Easter Sunday, only a handful of houses within the City had multiple cars at their house; Seems as though most people are taking the COVID-19 seriously and it is looking like May 1st things might let up; Sunrise Easter at Mill Pond Park there were approximately seventy-five to one hundred cars; the Ministerial Alliance is looking to make this an annual event and there was a lot of positive feed-back regarding this event; the Golf Course is closed to the General Public however, Private Members are allowed to play; One person per golf cart and they must exercise the six foot distance; the Club House is closed and they are not renting carts; the employees are still working due to they can't stop mowing and watering the greens or we will lose them; Lowes Grocery Gas is open at the old location; Crews are in town to demo Lowes and they will start demo tomorrow, Insurance Company finally opened up so they could start; will start looking at the Budget starting soon; most customers are paying their bills with no complaints.
